A Different Edition This Year

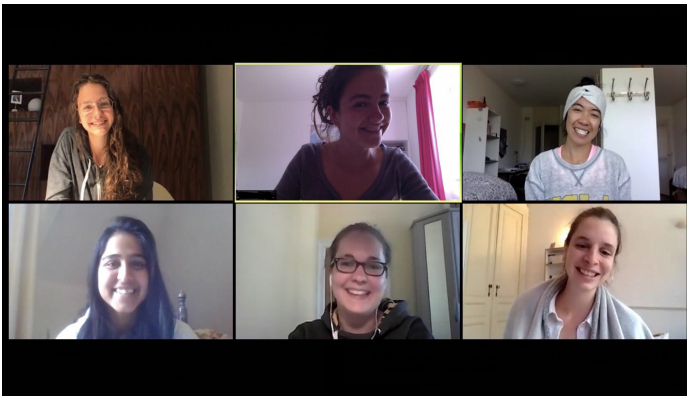

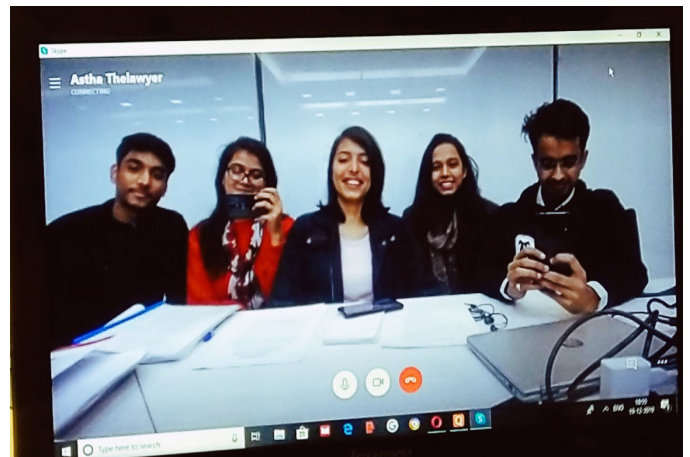

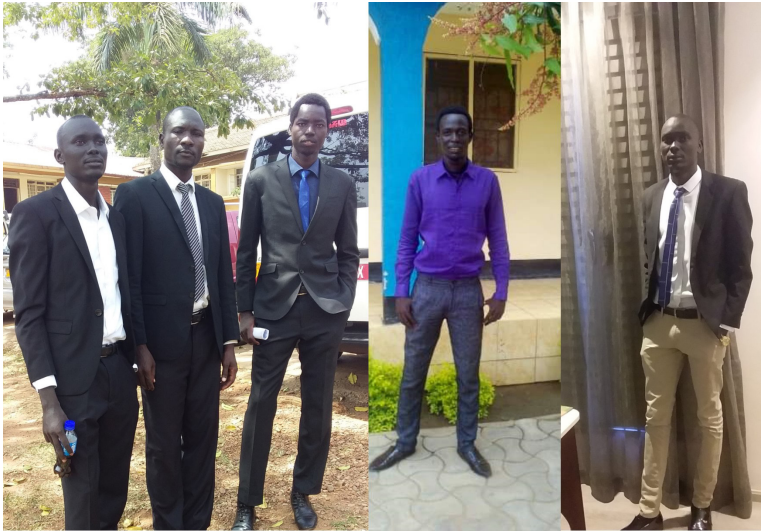
